#### <u>Safeguarding Adult Review and</u> <u>Learning:</u>

Safeguarding Adult Review: Adult AT and Adult AS - The SAR includes questions which could be used in for reflective practice/supervision or training sessions. The SAR draws on reflections of how we can encourage community awareness of abuse and neglect. This is something NSSAB are working on developing and new community flyers will be launched over the next few months.

#### World Social Work Day:

Social Work Week 2025 will take place from Monday 17 to Friday 21 March 2025, and will coincide with World Social Work Day on Tuesday 18 March 2025. This year's theme is 'Strengthening Intergenerational Solidarity for Enduring Wellbeing', which emphasises the importance of caring and respecting across generations to build strong societies, sustain the environment, and share wisdom for a better future.

## The Assisted Dying Bill

The Terminally III Adults (End of Life) Bill is currently progressing through the UK Parliament. It started in the House of Commons and has passed through several stages, including the first and second readings, committee stage, and report stage. It is now in the House of Lords, where it has also passed the first and second readings and is currently at the committee stage.

The bill includes several safeguarding controls to ensure the process is safe and ethical:

- 1. Eligibility: Only adults aged 18 or over, diagnosed with a terminal illness expected to result in death within six months, can apply
- 2. Voluntary and Informed Decision: The individual must make a voluntary, clear, settled, and informed wish to end their own life, confirmed by two doctors
- 3. Declaration: The individual must sign a declaration in the presence of an independent witness, which is then countersigned by an attending doctor and an independent doctor
- 4. Judicial Oversight: The High Court (Family Division) must approve all cases to ensure compliance and protect vulnerable individuals
- 5. Self-Administration: The patient must self-administer the prescribed life-ending medication, ensuring the final act remains their own choice
- 6. Healthcare Professional Participation: Healthcare professionals are not obligated to participate in the process, preserving individual ethical considerations

This report considers the early deaths of five people, who had all experienced traumatic things in their lives that led to their neglect of their own care and wellbeing. This was seen as **"passive suicide"**. The report found that to address self-neglect and promote wellbeing, practitioners needed to address the underlying **trauma** in people's lives, using a **whole family and Think Family approach.** 

#### SARs and Coronial Processes Best Practice Guidance

This guidance has been developed by the National Safeguarding Adults Board Manager Network in response to feedback from Safeguarding Adults Boards (SABs) and learning from Safeguarding Adults Reviews (SARs) that the interface between SARs and Coronial Processes can be difficult to navigate.


