MARM

Claire Kidley presented her final update before finishing in her post. Claire has now moved to Oxfordshire to take on the MARM role there. She did a great job and will be really missed here in North Somerset. The recommendations presented to SAB were.

The MARM pathway should become an ongoing offer to support agencies to manage high level risks for individuals, where other forms of intervention through business as usual have not been able to mitigate these risks.

The MARM Coordinator role should become permanent, with North Somerset Council hosting or partners will need to take on the role of facilitating MARM.

Consideration of continuing the role of business support to support the MARM Coordinator. Currently supported from existing NSC Quality Monitoring resource.

Training to be provided by MARM to agencies in relation to the MARM process, the eligibility criteria, how professionals can make a referral, what to expect from an Initial MARM meeting and review meetings to ensure effective use.

MARM to be promoted through advertising, meetings with agencies and bitesize learning sessions.

Continuation of evaluation for future MARM offer; July 2025 would be one year from the first meeting being held. This review to look at further outcomes for individuals and services to see where MARM has made a difference and

opportunities for continued improvement.

Consideration be given to the service gaps identified and strategy to reduce these to enable beneficial outcomes for people with complex and high risk.

Phil Wilshire AWP

Phil came along and presented AWPs 'Your Team - Your Conversation-Your Plan' This is the Personalised Care and Support Planning approach that will replace CPA across AWP. Your Team Your Conversation Your Plan was co-designed with experts-by-experience and staff from AWP, Primary Care, VCSE, ICB and Local Authorities. Adopting an approach that produces a simple plan will free staff time to concentrate on building relationships, communicating effectively and delivering meaningful interventions. Work of our Subgroups:

Statutory SARs in Progress:

NS SAR 1 RC – Lead Reviewer Stella Smith. Themes are around exploitation, cuckooing and suicide in care home. The first panel meeting has taken place, and a practitioner review is currently being planned.

NS SAR 2 Kyran - Expression of interest of the role of a lead worker have gone out. This SAR is likely to contain learning around self-neglect and diabetes management.

Family Care Giver Abuse - North Somerset DHR 6 flagged up issues in relation to the identification of risks of homicide and suicide in family care giver relationships. These have also been recognised in a number of SAR referrals received to the SARC. A Family Care Giver Abuse Task and Finish Group is therefore in the process of development to review research in this area and provide a series of recommendations to the board in relation to how the risk of homicide and/or suicide can be identified and addressed in family care giver relationships. No date for the first meeting has yet been agreed but reading for the task and finish group have been shortlisted with the support of Karen Gray (Bristol University) and Kath Leman (NS Principle OT). There is still space for people to express an interest in this work.

Quality and Performance

We have made the decision to pause the Q&P Sub-group for the time being. This is because on two recent occasions we have been unable to run the sub-group due to not being quorate. We will be continuing to discuss data and be a part of the SAB joint Police data sharing group and associated work plan items will be discussed via the Chairs Group which can then in turn inform board. We will ensure smaller task and finish groups are established where the need arises, and we will monitor the situation closely.

Learning and Development

Set up a meeting with chairs from other L&D subgroups has been completed and has been successful. Recurrent meeting in place now and we can use to look at regional L&D options. Looking at aligning and working together, opportunity for collaborating and sharing resources.

Lunch and Learn Webinars being discussed and planned. Planning to run them throughout the year on local and national themes identified in SARs. Emails gone out for people to contribute to the sessions. Launching in next 6 weeks. Themes are: Mental capacity, Professional curiosity, Family care giver, Care home suicide, DHRs and Romance fraud, MARM.

The NSSAB multi agency policy and procedures subgroup have been working hard and you can now see updated and republished documents for, Pressure Injury Protocol, Missing person protocol, Medication Error Protocol, Managing allegations against people in a position of trust (PiPoT), Financial Abuse Toolkit, Communications Protocol, Whistleblowing Policy, Local North Somerset multi-agency safeguarding procedures (If you work across local authorities you will need to see the regional policy, located next to this), Self Neglect Protocol. De-hoarding Pilot

North Somerset Council have a contract with five organisations; Additional organisations can be added to the framework as we monitor and evaluate success. All organisations have staff DBS checks in place, insurance cover, training, and other relevant policies in place. These have been checked as part of our due diligence. In addition to the pilot, we will be working closely with Respect My Stuff to deliver some local training and to develop a local support group to provide a free, informal, and relaxed environment to those who hoard, to talk, learn and support each other.
